Individual Resident Tax Collection Method ~information for employers~

(個人住民税の徴収方法 ~事業主の方へのお知らせ)

Form fiscal year 2016 (*Heisei* 28), Shiga prefecture and all the municipalities of Shiga will thoroughly call on every employer who has obligation to collect income tax of the emproyees, to collect also Individual Resident Tax by withholding from salary of the emproyees, in order to to pass it to the government. This resident tax collection system is called "*Tokubetsu-Chōshū* (*special collection*)" in which employers are going to withhold resident tax from the salary to be paid to employees every month and pay it to the government, in the same way as withholding income tax. * Income tax: *Shotoku-Zei* (所得税) * Individual resident tax: *Kojin-Jumin-Zei* (個人住民税)

Good point of "Tokubetsu-Chōshū (special collection)" for employment income earners (employees)

If your resident tax is collected by **"Futsū-Chōshū (ordinary collection)"**, you will pay in 4 installments a year by means of payment form which is mailed to you or direct debit from your bank account.

Prevention from infectiouns diseases apt to be caught in winter season

■Influenza

Three essential points for preventing the infection

- 1. Use a mask when you have a cough or sneeze. If you don't have a mask, cover your nose and mouth with tissue paper.
- 2. Wash your hands frequently
- 3. Gain resistance to infectious diseases, with sufficient sleep, a well-balanced diet, proper exercise, and hydrating yourself

When you suspect you have caught the flu.....

When you have a sudden fever, cough, sore throat, or musclar pain, and suspect flu infection, you should see a doctor wearing a mask. Even after the temperature gets back to normal, it is needed to refrain from going outside for 3 to 7 days from the beginning of the symptom.

Early vaccination against influenza

With the vccination, it is expected to prevent from making the illness more serious and or to minimize the health damage. After taking the vaccine, it takes nearly 2 weeks to have the effect, so it is recommended to have a vaccination against influenza as soon as possible.

People over 65 years old can have a flu vaccination at a cost of ¥2,000. For further information, please contact Health Promotion Division.

■Norovirus

Norovirus food poisoning is mainly caused by eating contaminated food prepared by a infected person. Norovius is a very contagious virus and can cause an outbreak of mass food poisoning.

PREVENTING NOROVIRUS FOOD POISONING

- 1. Wash your hands carefully
- 2. Cook foods thoroughly

-Heat sufficiently until the center of the food keep heated over 90 seconds at 85°C or above. -Don't touch cooked foods with hands when serving it on dishes. Use hashi or kitchen utensils.

- 3. When you have a symptom such as diarrhea and vomit, you should not prepare food.
- 4. Sterilize tableware and kitchen utensils steadily
- 5. Disinfect properly at the disposal of the vomit or feces,

THOROUGH HAND-WASHING

-Wash your hands : - before cooking

-before eating

-after using the toilet

-after changing diapers,

-after handling soiled items of the patients

-Keep your nails cut short.


-When washing hands, take rings off and use soap and brush to wash fingers.

-Then rinse your hands with running water thoroughly, and dry with a paper towel or a towel for your use only.
