Final Income Tax Return

must be filed between Feb. 16th (Mon.) and Mar. 16th (Mon.)

Final Income Tax Return is a procedure to adjust your income tax which is calculated based on all your net income earned for 1 year between January 1 and December 31.

Who must file for final income tax return?

- ① The amount of income is more than that of income deduction.
- (2) Those who earned more than ¥20,000,000
- ③ Total income, excluding salary income and retirement income, is more than ¥200,000.
- (4) Those who have income from 2 or more companies and earned more than ¥200,000 excluding salary income without year-end tax adjustment and retirement income

**Even if you do not need to file a tax return, you may get a tax refund by filing medical deduction, etc.

What do I need to bring to file for income tax return?

1 INKAN / personal seal

(2) Statement of earnings

-GENSEN-CHŌSHŪ-HYŌ 源泉徴収票 (original, not a copy) ➤ for those who have pay and/or pension -SHŪSHI-UCHIWAKE-SHO 収支内訳書(balance report)

► for those who have income regarding farming, self-employed business and real estate -If you have income other than the above, you need a document that proves the income.

③Documents required to file tax deductions

Example. - Certificate of payment for KOKUMIN-NENKIN-HOKEN-RYŌ 国民年金保険料

(National Pension insurance premium) -Certificate of payment for public health insurance premium under the voluntary enrollment system -Certificate of payment for premiums if enrolled in life insurance or earthquake insurance -Receipt of medical expenses

④ If your tax paid is expected to be refunded, bring a document proving your bank account information such as account number, name of the bank and branch name.

★ If you need a payment certificate for *KOKUMIN-KENKŌ-HOKEN-ZEI* (National Health Insurance tax), KAIGO-HOKEN-*RYŌ* (nursing insurance premium), or *KŌKI-KŌREISHA-IRYŌ-HOKEN-RYŌ* (medical insurance premium for the elderly) they will be issued for free at: City hall (Minakuchi office), Chiiki-Shimin-Center of Tsuchiyama, Koka-Ohara, Konan-Daiichi and Shigaraki.

★ Regarding certificate of payment for *KOKUMIN-NENKIN-HOKEN-RYŌ* (National Pension insurance premium) If you have paid National pension insurance premium during 2014, Japan Pension Service sends the certificate of payment so that you can attach it for tax deduction.

Where do I file for income tax return?

Allowance for school enrollment is available for single parent households

(ひとり親家庭等入学支度金)

In order to better secure childrens' health and growth, Koka City is providing an allowance for single parent households with child(ren) entering an elementary and/or Junior High School.

- Eligibility: As of February 1st 2015, applicant must be a registered resident of Koka City for more than one year. Additionally, the applicant must be a single parent or a foster parent of child(ren) who will enter an elementary or Junior High School in April, 2015.
- Application period: <u>February 2nd (Mon.) to February 27th (Fri.)</u> 8:30am to 5:15pm *excluding weekends & holidays
- Amount: 5,000 yen for entering elementary school 10,000 yen for entering Junior High School
- > Allowance will be paid: on March 27th (Fri), 2015 *tentative
- Where to apply: Reception desk at City Hall in Minakuchi, Chiiki Shimin Center of Tsuchiyama, Koka-Ohara, Konan-Daiichi, and Shigaraki
- * Please note that the application submitted after the application period will not be accepted.
- * We won't send the notice to eligible persons. Application is required for the allowance.

Mutual-Aid Insurance Plan for Traffic Accident for FY 2015

Application period

From February 2nd (Mon.)

(平成 27 年度交通災害共済)

This is a mutual aid system, where each member pays a small amount of contribution and can receive a benefit (relief money) in case of meeting with an traffic accident. The application is available now.

Who can join in this insurance? -Those who are registered as a resident in Koka City

-Those who work or study in Koka City

Period covered by the insurance April 1st, 2015 to March 31st, 2016

Where to apply

¥500 / person

Premium for 1 year

Application should be made at City Hall (Minakuchi), *Chiiki-Shimin-Center* or financial institution located within Koka City. Application form is available at City Hall, and also will be distributed to each household through local residents' association.

Benefit

When you suffer an injury in an accident caused by vehicles on the road in Japan during the insured period, and receive treatment in a hospital, a benefit will be offered.

Amount: ¥20,000 to ¥1,000,000 at the maximum(in case of death)

The amount of the benefit depends on degree of the injury. Depending on circumstance of the accident, the benefit may not be paid.
