Updated NHI card, by registered mail, will be sent by the end of March. (国民健康保険の保険証発送) The card will be available from April 1st.

If you are not at home when the card is delivered, please go to the post office within the storage period (10 days usually) to receive it, or contact the post office to let them know about the date of re-delivery you wish.

After the storage period in the post office has passed, the card will be kept in City Hall. Please contact Insurance and Pension Division and receive it at the division or *Chiiki-Shimin-Center* of Tsuchiyama, Konan-Daiichi, Koka-Ohara or Shigaraki. If you can not to come to any of the places above, we will be able to send it again after your request.

*Documents required to receive at City Hall or Chiiki-Shimin-Center:

-Identification document,

-expired NHI card,

-personal seal,

-proxy(if someone other than members of the household receive it)

<u>When receiving updated card(s)</u>, please check if you have the card(s) of all NHI insured persons in your household, and also verify name and date of birth of each card. Health insurance card must not be lent or borrowed.

Transfer or Disposal of Light Vehicle Registration(軽自動車の名義変更・廃車手続き)

Light vehicle tax is imposed on registered owners of motorcycle, small-sized special motor vehicle, light motor vehicle, etc, as of April 1^{st} every year. If you meet the following, please carry out the procedure of transfer or disposal before April 1^{st} .

-Owner has changed to another member of the family -The vehicle is very old, and have not used for a long time

-Handed over to another person -Owner died
