National Pension Insurance Premium Discounts

for Direct-Debit Payments

For National Pension Insurance Premiums, direct-debit payment is convenient. Also, one collective payment (pre-payment) is entitled for premium discounts.

For direct-debit transfer application, please proceed to the financial institution counter or at Kusatsu Nenkin Jimusho (Kusatsu Pension Office) for processing.

Necessary for Processing:

- · Payment Notice or Pension Insurance Passbook
- · Registered seal (inkan) for the said financial institution
- Direct-debit transfer application form (※)
- (※) Aside from the financial institution and pension offices, application forms are also available at the Insurance Pension Division, former sub-stations in Tsuchiyama · KōkaŌhara · Kōnan Dai-1 · Shigaraki Chiiki-Shimin Center.

National Pension Insurance is a mandatory subscription for those who are at the age of 20 until below 60 and with an address in Japan.

National Pension premiums should be paid properly and accurately for their own future.

If insurance premium payment is difficult, please ask for a consultation regarding case correspondence on exemption / postponement system.

◆"National Pension Insured Notification for Qualification Acquisition" will be sent before within the month of the 20th birthdate. Please fill up the necessary information required and submit to the Insurance Pension Division or to the Chiiki Community of the former sub-stations.

TAX RETURN DECLARATION OF MINAKUCHI TAX OFFICE WILL BE AT: MINAKUCHI SHAKAI FUKUSHI CENTER Fukushi Hall

The tax declaration venue is very crowded

Using personal home computer, in the National Tax Agency website, please use the "TAX DECLARATION, etc. CREATE CORNER".

"TAX DECLARATION, etc. CREATE CORNER" is very convenient.

《●: NO NEED TO GO TO THE TAX OFFICE》

With My Number Card and IC Card Reader-Writer, declarations, etc., can be created and sent using e-Tax at home.

Also, print the created declarations, etc., and submit it to the tax office through postal mail, etc.

2 : POSSIBLE TO CREAT AT ANY TIME

During the period of filing the tax declaration, etc., it can be utilized within 24hrs. including holidays.

«3: AUTOMATIC TAX AMOUNT CALCULATION»

By inputting the amount of income and deductions, the tax amount is automatically calculated.

《●: IT CAN ALSO BE CREATED ON TABLET TERMINALS, etc.≫

The declarations can be printed through the printing services in the convenience stores, etc. In addition, it is necessary to print the declaration and submit through postal mail.

Information regarding tax return venue

Due to the crowded declaration venue, it may be a long time to wait. The consultation reception is until 4:00pm only. Also, in some circumstances, the consultation reception hours may be closed earlier.

XPaying taxes cannot be made at the venue. (Please pay at the Tax Office or financial institutions nearby.)

Make sure to write "My Number" in the Declaration

◆Along with the Social Security · Tax-number System (My Number System) in the declaration on and after year 2016, the descriptions of My Number (taxpayer itself), qualified deductible spouse, dependents, as well as business professionals is compulsory. During the submission, taxpayer itself must present or attached a copy of an identity confirmation document. My Number Card
