Partial Subsidy for "Recurrent Miscarriage" Treatment Expenses

Within a half of the cost for Recurrent Miscarriage treatment as well as the treatment-related medical examinations costs outside medical insurance coverage, in a year, up to 300,000 yen will be subsidized.

Eligible Recipients:

Those who are diagnosed for inability to carry a pregnancy in full term and in need of treatment, as so as for those who falls under the following:

- •Legally married couple.
- Either one or both of the couple whose bearing a continuous resident registration in Koka City, from a year before the grant application date.
- Those who do not have delinquent city tax payments.

Methods of Procedures:

Please fill up the necessary information on the application form for direct-debit transfer (provided on each financial institutions within the city), apply directly to the counter of your desired financial institutions after affixing your official bank account seal. Payment transfer usually starts from the following month onwards.
