In the recent years, vacant houses are increasing due to aging and nuclear families. Furthermore, since vacant houses, etc. are not properly managed, adverse-effects in the living environment such as disaster prevention, sanity, scenery, and the like, have been a problem nationwide. As a result of the Beauty Measures Environment Field Inspection, it was found that there are 1366 vacant units within the city.

In the country, as of year 2015, "Special Measures Law concerning Promotions of Counter-measures for Vacant Units, etc." was fully implemented. Also in the city, starting April this year, for the up-taken progress enhancement of "KOKA CITY Ordinance on Proper Management and Utilization of Vacant Houses, etc." will be enforced for the realization and conservation of safe and reliable good living environment. For further details with regards to the ordinance, please refer to the city website.

The proper management of vacant units, etc., is the responsibility of the property owner. Please do the appropriate ownership management.

Aside from consultations regarding utilization and management of vacant units, etc., for those who experience any problem due to improper management of vacant houses in the neighborhood, please consult to the contact nos. below. The office will try to communicate and convince the owner on proper management of the house.



On the  $3^{rd}$  of March, in focus with the Doll Festival, until March  $8^{th}$ , the International Women's Day, within 8-days, was stipulated as "Women's Health Week",

Women are expected for further activeness in their homes, workplace and communities. Women themselves who are energetic throughout their lives lead the society as a whole as well. First of all, for women to have long and fulfilling days of life, she must know the right information about the body and illness, prevention of diseases, and health management including early detection of sickness.

Cancer in Women

In recent years, breast cancer and cervical cancer was jound rapidly increasing, and yet, complete recovery can be expected with an early treatment,

- ●BREAST CANCER It was said that 1 out of 12 women acquire this, rapidly increase at the age of 30's, and peaked at the age of late 40's and 50's. Besides the screening, it is also important to perform self-palpitation check in a regular basis.
- ●CERVICAL CANCER It rapidly increase from the age of 20's ~30's. Since cervical cancer has a minimal initial subjective symptoms, periodic medical examination is important. If it progressed, there are cases that the total removal of the uterus will be required.
- Lifestyle leading to Cancer Prevention
- To smokers, stop smoking as soon as possible.
- Refrain from fats, instead, take beans, soy products and fishes.
- ■Eat vegetables and fruits regularly.
- Keep appropriate amount of alcohol drinking.
- ■Moderate exercise should be a habit.
