You can use your Individual Number Card to get a copy of your resident register and various other certificates using the multi-copy machine at convenience stores nationwide. If you still don't have an Individual Number Card, then let's make you one - it's so useful to have!

# Coupons for the Booster Shot (Third Dose) of the COVID-19 Vaccine Will Be Sequentially Sent in the Mail

We are already sending vaccination coupons to the following people in order: medical staff, people working and staying at facilities and other places where elderly people are, people who received their second dose of the vaccine between May and July, 2021.

We will continue sending the vaccination coupons based on the Ministry of Health, Labour and Welfare's policy on the interval between vaccinations. Generally, the coupons will be sent from one month up to two weeks before the date you are eligible for the third dose of the vaccine.

**You must have a vaccination coupon** to book an appointment for a vaccination and to receive the vaccine. Please have the vaccination coupon ready with you when booking an appointment and receiving the vaccine.

The vaccination coupons are currently being sent in order based on the date you received your second dose in 2021 (starting with those who received the vaccine earlier in the year). If you still haven't received your coupon after some time, please inquire at the number listed below.

# Do You Know about the Welfare Allowance for Children with Disabilities and Allowance for Persons with Special Disabilities?

Koka City provides allowances to persons with severe disabilities who remain at home and require constant nursing care. For both allowances, certification with a medical certificate, etc., is required, and there is an income limit.

#### Welfare allowance for children with disabilities

Eligible persons Those under 20 years old who remain at home and require constant nursing care in their everyday lives due to severe mental or physical disabilities

Amount ¥14,880 per month

### Allowance for persons with special disabilities

Eligible persons Those aged 20 years or older who remain at home and require constant and special nursing care in their everyday lives due to extremely severe mental or physical disabilities

Amount ¥27,350 per month

You can still apply for the allowance, even without a physical disability certificate, etc.; however, you may not be eligible to receive the allowance depending on the type and condition of disability.

# Remember to Apply for the **Admission Allowance**

## for Single-Parent Households

# Reduction in the per Capita Rate of National Health Insurance Tax for Children

From fiscal 2022, in order to lessen the financial burden on child-rearing households, the per capita rate of National Health Insurance (NHI) tax for children (only preschool age) will be reduced by 50%.

There is no need for NHI subscribers to complete any special procedures to receive this reduction.

#### Example:

· Four-person household (father, mother, two children) (Ages: head of household 35 years, spouse 33 years, child 4 years, child 1 year)

Household income in the previous year

(Head of household: business income of ¥2.8 million, spouse and children: no income)

- Only those registered as residents of Koka City as of January 1, 2022, may file tax returns at venues in the city.
- · Please use public transportation, etc., whenever possible, because there is limited space in the parking lots at each venue.
  - In the following cases, please file your tax returns at the filing venue in the Minakuchi Tax Office (East side of the Welfare (Fukushi) Hall, 1F, Minakuchi Social Welfare (Shakai Fukushi) Center).
  - Returns including capital gains (income derived from the sale of land, shares, etc.)
  - Returns in which deductions will be received for casualty losses
  - Returns in which special credit for loans, etc. related to a dwelling will be received for the first time
  - Blue returns, consumption tax returns, final returns for 2020 or before, and tax returns for deceased persons (quasi-final returns)
  - Returns with total business income (agriculture, sales, etc.) of 10 million yen or more
  - · Returns with retirement income
  - · Returns with other complicated contents

#### Measures to Prevent COVID-19 Infection

The following measures will be taken to prevent infection at the consultation venues. We appreciate your understanding and cooperation.

- · Disinfectant will be placed at each entrance/exit.
- · Acrylic barriers will be installed between visitors and service staff to prevent infection via droplets.
- The body temperatures of all visitors will be checked.
- The entry of visitors may be restricted to avoid the 3Cs in venues.

#### Requests to visitors

- Please wear a mask and disinfect your hands/fingers at the entrance when entering the venue.
- Visitors who have a temperature of 37.5°C or higher, do not wear a mask or have cold symptoms, such as a cough, may not be allowed to enter the venues.
- · Please come to the venue alone. If you need assistance, please bring the minimum number of people necessary.

### **✓** Check the items needed for tax returns

- (1) Individual Number Card OR notification card or other document verifying your individual number plus a driver's license or other identification document
- (2) Documents showing your income
  - Withholding tax slips for salary or pension (original)
  - Statement of earnings and expenses for any business, agricultural or real estate income (only if applicable)
  - \*Please make sure to prepare these items in advance.
  - For those with income other than the above, documents showing that income
- (3) Certificates for deductions, etc.
  - Documents showing the payment of social insurance premiums (national pension insurance premiums and voluntary and continuous health insurance premiums)
  - Certificates of payment of premiums for life insurance, earthquake insurance, etc.
  - Statement of deduction for medical expenses
     \*Please make sure to prepare these items in advance.
     (Enter the names of the medical care recipients for each hospital and the total amounts of the expenses.)
    - \*A notice of medical expenses is also accepted.
  - Statement of deduction for medical expenses by the self-medication taxation system (those who claim this deduction will not receive the normal medical expense deduction.)
  - Other documents needed for deductions to be received
- (4) If payment of taxes or receipt of a tax refund by bank transfer is expected, a document showing the account number of the filer, name of the financial institution and branch name
- (5) A document showing the income of dependents for the determination of dependent deductions,
- (6) A copy of last year's tax return (if you have it)

  \*Certificates of payment of national health insurance taxes, nursing-care insurance premiums or medical insurance premiums for older senior citizens do not have to be attached to tax returns.

#### If you have a nursing care certification

#### With this certification from the city, you can claim a deduction for persons with disabilities

As of December 31st, 2021, you can receive a deduction on your taxes if your family member is 65 years or older and has a physical or mental condition that meets certain standards (such as being bedridden or having dementia). You do not need to have a disability certificate or other such documents issued. However, you must apply to receive a Certificate of Eligibility for a Disability Deduction (Shogaisha Kojo Taishosha Ninteisho) to be eligible for the deduction.

#### Issue of confirmation form instead of a Diaper Use Certificate

If you plan on filing for a medical expenses deduction for the cost of diapers, you must receive a Diaper Use Certificate from your family doctor for the first year you file for the deduction. However, from the second year onwards, if you meet certain criteria, you can apply to receive a Confirmation of Necessary Items to Certify a Medical Expenses Deduction for the Cost of Diapers (Omutsudai no Iryohi Kojo Shomei Hitsuyo Jiko no Kakuninsho), and use this confirmation form (instead of the Diaper Use Certificate) to file for the deduction.
