

Free Vaccination for COVID-19 to End in March 2024

Free vaccination for COVID-19 will end on March 31, 2024. Please note that the schedule and end date of the vaccination differ at each medical institution. For individual vaccination medical institutions, please check the Koka City website or the information enclosed with your vaccination coupon.

• Please note the interval of the initial (1st and 2nd) vaccinations

The initial vaccination for those aged 5 years and older is completed with two doses. In order to complete the initial vaccination during the special temporary vaccination period (until March 31), it is necessary to proceed with consideration of the vaccination interval (usually 3 weeks after the first dose for Pfizer vaccinations). If you wish to be vaccinated, please make arrangements as soon as possible.

Have you heard about...The Welfare Allowance for Children with Disabilities and Allowance for Persons with Special Disabilities?

Koka City provides allowances to persons with severe disabilities who remain at home and require constant nursing care. For both allowances, certification with a medical certificate, etc. is required.

You can still apply for the allowance, even without a physical disability certificate, etc.; however, you may not be eligible to receive the allowance depending on the type and condition of disability. In addition, there are income limits and you may not be eligible for the allowance.

Starting in April, we will expand medical subsidies for children aged 16 to 18 and the mentally disabled

In line with the expansion of the Shiga Prefecture system, from April, children aged 16 to 18 and those with a level 1 mental disability health and welfare certificate, etc., will receive full subsidies for their out-of-pocket expenses for covered medical expenses. A welfare medical expense receipt ticket (subsidy ticket) is required to receive the subsidy. Please be sure to complete the grant application process.

*Individual notifications will be sent to those who may be eligible in mid-February. Please check the Koka City website for details.

*Children who are currently 9th grade (third year of junior high school) and have a Child Rearing Support Medical Expense Receipt Ticket (cream color) do not need to apply. We will send you the receipt ticket after March 21.

*If you are already under the Welfare Medical Expense Subsidy System for people with severe mental or physical disabilities, single-parent households, etc., this new system will take precedence over it, so you will be sent information about the system switchover.

Please file your tax returns via the Internet ("e-tax") or by post, if possible. Preparation and submission of tax return can be done through the National Tax Agency website.

• Tax Office Filing Venue The following declarations will be accepted at the tax office filing venue.

- Returns including capital gains (income derived from the sale of land, shares, etc.)
- Returns in which deductions will be received for casualty losses

Check the items needed for tax returns

(1) Individual Number Card OR notification card or other document verifying your individual number plus a driver's license or other identification document

(2) Documents showing your income

- Withholding tax slips for salary or pension (original)
- Statement of earnings and expenses for any business, agricultural or real estate income (only if applicable) *Please be sure to prepare these items in advance.
- For those with income other than the above, documents showing that income

(3) Certificates for deductions, etc.

• Documents showing the payment of social insurance premiums (national pension insurance premiums and voluntary and continuous health insurance premiums)

*Certificates of payment of national health insurance taxes, nursing-care insurance premiums or medical insurance premiums for older senior citizens do not have to be attached to tax returns. If necessary, applications can be submitted online.

- Certificates of payment of premiums for life insurance, earthquake insurance, etc.
- Statement of deduction for medical expenses

*Please be sure to prepare these items in advance. (Enter the names of the medical care recipients for each hospital and the total amounts of the expenses.)

- *A notice of medical expenses is also accepted.
- Statement of deduction for medical expenses by the self-medication taxation system
- (Those who claim this deduction will not receive the normal medical expense deduction.)
- Other documents needed for deductions to be received

(4) If payment of taxes or receipt of a tax refund by bank transfer is expected, a document showing the account number of the filer, name of the financial institution and branch name

(5) A document showing the income of dependents for the determination of dependent deductions, etc.

(6) A copy of last year's tax return (if you have it)

If you have a nursing care certification

With this certification from the city, you can claim a deduction for persons with disabilities

You can receive a deduction on your taxes if a family member is 65 years or older and has a physical or mental condition that meets certain standards (such as being bedridden or having dementia) even if they do not have a disability certificate or other such documents issued as of December 31st, 2023. However, you must apply to receive a Certificate of Eligibility for a Disability Deduction (Shogaisha Kojo Taishosha Ninteisho) to be eligible for the deduction.

Issue of confirmation form instead of a Diaper Use Certificate

If you plan on filing for a medical expenses deduction for the cost of diapers, you must receive a Diaper Use Certificate from your family doctor for the first year you file for the deduction. However, from the second year onwards, if you meet certain criteria, you can apply to receive a Confirmation of Necessary Items to Certify a Medical Expenses Deduction for the Cost of Diapers (Omutsudai no Iryohi Kojo Shomei Hitsuyo Jiko no Kakuninsho), and use this confirmation form (instead of the Diaper Use Certificate) to file for the deduction.

Please attach this certificate or payment receipts when filing your final tax return. The garbage collection frequency and sorting categories will change from April

Collection frequency

- Plastic bottles will be collected twice a month instead of once a month.
- Collection of plastic waste will be reduced once per month, from 4-5 times per month to 3-4 times per month. (Please note that this will no longer be a weekly collection.)



Separation category

 Currently, metals and small electrical appliances are separated, but they will be collected together as metals and small electrical appliances.

*The garbage collection calendar for fiscal 2024 will be distributed by wards and community associations from mid-February. Assistance for those who have difficulty disposing garbage

For elderly or disabled households that have difficulty disposing of garbage at collection points, Eisei (Sanitation) Center, etc., we make door-to-door collection visits for garbage left at their doorsteps, etc. This service reduces the burden on the elderly and disabled in their daily lives, and watches over them according to their garbage disposing status, etc.

• Eligible households are asked to place their garbage in garbage cans with lids placed at their doorsteps, etc. by the designated date and time.

The garbage will be collected door-to-door by a collection contractor.

- Burnable garbage should be placed in the designated bags for burnable garbage, and recyclable garbage should be placed in bags of your choice.
- Burnable garbage is collected once a week and recyclable garbage once a month.

*If garbage is not put out, we will ring the doorbell, etc.

- OHouseholds that have difficulty in carrying garbage to collection points or Eisei (Sanitation) Center, etc., and that meet or are equivalent to the following criteria, are eligible.
- Households consisting solely of persons 65 years of age or older who are certified with nursing care certification or those who have been issued a physical disability certificate, a medical care certificate, or a mental disability health and welfare certificate
- Households using nursing care insurance services or households using welfare services for persons with disabilities and receiving assistance with household chores

What is Selective Medical Expense?

It is a fee charged for outpatient visits to hospitals with 200 or more beds without a letter of referral. (Kohka Public Hospital: 7,700 yen (with tax) for medical care)

A Safe City Preventing Traffic Accidents on Snowy and Icy Roads — Preparation is the key to safe driving in winter—

Points for Safe Driving on Snowy and Icy Roads Keep a longer distance between vehicles than usual! Allow 2 to 3 times more space between vehicles than you would on sunny days. Be careful of black ice!

- Even if the road looks wet, it may be icy.
- **Do not drive in a rush!** Rushed acceleration, rushed braking, and rushed steering can cause slipping.
- Be sure to prepare before you go out! Change to studless tires, bring tire chains, etc., and check road traffic information.
