From March, Apply for a Copy of Your Family

Register, etc. at a Counter Other Than Your Registered Location of Domicile



With the partial amendment of the Family Register Act on March 1, 2024, it is now possible to request a copy of family register, copy of closed family register, etc. at the counter of any municipality, not only the registered location of domicile.

This allows you to make a request for a family register from anywhere in Japan at the Koka City counter.

Please check the Ministry of Justice website for details.

[Important Information]

• Only a certified copy of the family register, etc. can be requested. (Extract of family register cannot be requested)

Those who can request a wide-area issuance of family registers, etc.

- Applicant
- Spouse
- Parents, grandparents, etc. (lineal ascendant)
- Child, grandchild, etc. (lineal ascendant)






*The request must be made at the counter by a person who is able to request the family register, etc.

• Requests cannot be made by mail or by a representative (authorization letter).

Notice on the COVID-19 Vaccine Information from April and the End of Service

Vaccinations for COVID-19, which have been provided as special temporary vaccination at full public expense (no payment by individuals), will end on March 31. From April, the vaccine will be positioned as a Class B disease under the Immunization Act and administered as a routine vaccination based on the Act, with the aim of reducing the number of serious cases by preventing individuals from becoming seriously ill.

Eligible Persons (1) Persons aged 65 or older (2) Persons aged 60 to 64 at high risk of serious illness (*)

*Those with heart, kidney, or respiratory organ dysfunctions that severely limit their daily lives, or those with immune dysfunctions caused by the human immunodeficiency virus (HIV) that make daily life almost impossible.

★ Those who are not eligible for routine vaccination but wish to be vaccinated can do so at their own expense as voluntary vaccination.

Fee In principle, some payment by individuals is required (amount to be determined)

(Vaccine Frequency/Vaccination Period) Once per year during fall and winter

COVID-19 vaccine available Selection will be based on the status of mainstream viruses in the pandemic and scientific findings on vaccine efficacy, and will be reviewed annually for the foreseeable future.

Rabies Preventive Group Vaccination for Fiscal 2024 will be Held

All dogs 91 days or older are required to be registered and must receive an annual rabies vaccination. Dog owners are advised to vaccinate their dogs at a group vaccination event or at a veterinary clinic.

For Koka City, rabies vaccination certificates and dog identification tags are provided by the Shiga Veterinary Medical Association.

Please contact Consumer and Environmental Protection (Seikatsu Kankyo Ka) for any changes in registration details, including when moving to a new address or if your dog passes away.

 - *Please complete the medical questionnaire attached to the postcard to ensure the vaccination proceeds smoothly.
 - *Consult your veterinarian before scheduling vaccination if your dog is pregnant, has just given birth, or has other health problems.

- Dog registration fee (¥3,000)
- Vaccination fee (¥3,500)

Reviewing Pet Owner Etiquette

Pets such as cats and dogs are important to people's lives, and so are the responsibilities and manners required for living with pets. The noise they make and the messes they leave behind (urine, feces, etc.) can be a nuisance to others, and failing to take care of these and other responsibilities can lead to problems with neighbors.

Let's take a moment to review some basic etiquette rules for pet owners.



OLiving with dogs

During walks

When you walk your dog, be sure to bring the tools necessary for cleaning up after your dog (including shovels and plastic bags for feces). Also, keep your dog leashed at all times.

Cleaning up feces

Dog owners failing to pick up their dog's feces is a big problem for local residents. Owners are always responsible for cleaning up after their dogs.

OLiving with cats

Keeping cats indoors

The outside world is a dangerous place for cats, exposing them to accidents and diseases.

Stray cats can also cause problems by leaving their feces and urine in unwanted places.

Spaying/neutering

Have your cat spayed or neutered to prevent the number of unwanted cats from increasing.

Preventing increased stray cat populations

Do not feed stray cats. Doing so can cause various problems in the community, including increased cat droppings, sounds, and damage to fields. If you want to feed stray cats, keep them indoors as members of your family.



Reception of Applications for Reduction/Exemption of 2024 Light Vehicle Tax (by Car Model) Starts from April

Applications for a reduction/exemption of the light vehicle tax (by car model) for light vehicles and other vehicles that meet the following conditions will be accepted during the application period.

Application Conditions

- Light vehicles, etc. that meet the conditions for use by individuals with a physical disability certificate, mental disability health and welfare certificate, medical care certificate, or war injury and sickness certificate.
- Light vehicles, etc. that are used by public institutions or local organizations for public service projects.

*Reduction/exemption eligibility depends on the ownership conditions of the light vehicle, etc., the disability category, and the certificate grade.

Application Period

April 1 (Mon) to May 24 (Fri)

*Note that applications will not be accepted after the application period.

Locations to apply

Taxation Affairs (Zeimu Ka), Community Civic (Chiiki Shimin) Centers in Tsuchiyama, Koka, Konan, and Shigaraki

Change the name on your light vehicle or scrap the vehicle as necessary

The light vehicle tax (by car model) must be paid by owners of motorized bicycles, specified small motorized bicycles, light three- and four-wheeled vehicles, and small special vehicles (agricultural vehicles, forklifts, etc.) on April 1 every year. Note that the light vehicle tax (by car model) must still be paid even if the name on the vehicle is changed or the vehicle is scrapped on or after April 2.

Be sure to change the name on the vehicle or scrap the vehicle by April 1 if the vehicle owner has changed (if the owner has become deceased) or if the owner no longer owns the vehicle.

*However, motorized bicycles, specified small motorized bicycles, and small special vehicles are subject to taxation if owned, regardless of their usage.

For those who are changing their name, address, or scrapping their vehicle outside of Shiga Prefecture

To change the name or address or report a vehicle as scrap for a light vehicle with a Shiga plate number subject to taxation in Koka City from outside of Shiga Prefecture, you must submit a tax declaration (tax suspension) application with Koka City.

If you forget to submit a tax suspension application, Koka City Hall will not keep track of your vehicle registration status and will continue applying the light vehicle tax (by car model).

Be sure to complete the tax suspension application—particularly for name changes (transfers of registrations) as tax notices will continue being sent to the owner on file, which may lead to unexpected problems.
