# Information about COVID-19

Infections at home are on the rise. Once again, we ask that you take measures to prevent infection.

### Four points for preventing infection at home

### Don't bring the virus into your home

Refrain from eating with anyone other than family members or others who usually reside with you

### Don't spread the virus at home

- Have separate meal times
- ✓ Partition rooms
- ✓ Wear a mask when more than one person is in the same room.

### Take measures to prevent infection in automobiles

- Ventilate the automobile in a reasonable manner
- Wear a mask

### Take sufficient basic measures to prevent infection

- ✓ Wash your hands when you come home and before you eat or drink
- Practice cough etiquette
- ✓ Don't share towels
- ✓ Ventilate rooms regularly
- Disinfect shared areas frequently



### **COVID-19 vaccinations**

Koka City has received a briefing from the national government and is currently preparing for COVID-19 vaccinations.

We plan to vaccinate healthcare workers and others starting at the end of February and to vaccinate elderly people aged 65 or older starting at the end of March.

Starting in April, submission of an application in advance will be required for direct delivery of large burnable waste to the Information Sanitary Center garbage disposal facility.



The Sanitary Center garbage disposal facility is currently undergoing a large-scale renovation, including the renewal of its aging incinerator (core facility improvement work), that is scheduled to continue for the four years from 2020 to 2023.

As the facility is expected to be very crowded during the renovation period, submission of an application at least one day in advance is required for direct delivery of large burnable waste to the garbage disposal facility.

#### Definition of large burnable waste

Burnable waste with total dimensions (length, width and height) of 80 cm or more \* Note that the definition is different from that of bulk waste in Koka City (waste with total dimensions of 1 m or more).









Also, incineration of burnable waste will not be conducted from July 3 to 18, so to the

extent possible, please refrain from disposing of burnable waste during this period.

Filing period February 16 (Tue.) to March 15 (Mon.), excluding Saturdays, Sundays and national holidays

- Only those registered as residents of Koka City as of January 1, 2021, may file tax returns at venues in the city.
- O Please use public transportation, etc., whenever possible because there is limited space in the parking lots at each venue.

### In the following cases, tax returns can only be filed via the filing venue in the Minakuchi Tax Office (east side of Welfare Hall, 1F, Minakuchi Social Welfare Center):

- Returns including capital gains (income derived from the sale of land, shares, etc.)
- Returns in which special deductions for loans, etc., related to housing will be received for the first time
- Returns with total business income (agriculture, sales, etc.) of 10 million yen or more
- Returns in which deductions will be received for casualty losses
- Blue returns, consumption tax returns, final returns for 2019 or before, and tax returns for deceased persons (quasi-final returns)
- Returns with other complicated contents

### **Measures to prevent COVID-19 infection**

The following measures will be taken to prevent infection at the consultation venues. We appreciate your understanding and cooperation.

- Disinfectant will be placed at each entrance/exit.
- Acrylic barriers will be installed between visitors and service staff to prevent infection via droplets.
- The body temperatures of all visitors will be checked.
- The entry of visitors may be restricted to avoid the 3Cs in venues.

#### Requests to visitors

- Please wear a mask and disinfect your hands/fingers at the entrance when entering the venues.
- Visitors who have a temperature of 37.5°C or higher, do not wear a mask or have cold symptoms, such as a cough, may not be allowed to enter the venues.
- Please come to the venues on your own. If you need assistance, please bring the minimum number of people necessary.

- Withholding tax slips for salary or pension (original)
- Statement of earnings and expenses for any business, agricultural or real estate income
- \* Be sure to prepare the statement in advance.
- · For those with income other than the above, documents showing the income

#### ☐ ④ Certificates for deductions, etc.

- Documents showing the payment of social insurance premiums (national pension premiums and voluntary and continuous health insurance premiums)
- Certificates of payment of premiums for life insurance, earthquake insurance, etc.
- Statement of deduction for medical expenses
   (Enter the names of the medical care recipients for each hospital and the total
   amounts of the expenses.)
- \* A notice of medical expenses is also accepted.
- Statement of deduction for medical expenses by the self-medication taxation system (those who claim this deduction will not receive the normal medical expense deduction.)
- \* For details, see the Koka City website.
- Other documents needed for deductions to be received
- ⑤ If payment of taxes or receipt of a tax refund by bank transfer is expected, a document showing the account number of the filer, name of the financial institution and branch name, as well as the seal registered for the financial institution
- □ ⑥ A document showing the income of dependents for determination of dependent deductions, etc.
- ☐ ⑦ A copy of last year's tax return (if you have it)
  - \* Certificates of payment of national health insurance premiums, long-term care insurance premiums or elderly medical care insurance premiums do not have to be attached to tax returns.

# For those who pay pension premiums

Those who paid National Pension premiums during 2020 will receive a social insurance premium (National Pension premium) deduction certificate from the Japan Pension Service. Make sure to attach the certificate or receipt to your tax return when you submit it. If you wish to claim a deduction for medical expenses, you will need to attach a statement of deduction for medical expenses instead of submitting the receipts. You can prepare a statement of deduction for medical expenses on the website of the National Tax Agency.

## Have you applied for the Temporary Special Benefit for Single-parent Households?

If you are eligible for the Temporary Special Benefit for Single-parent Households and have not applied for it yet, please submit an application before the deadline.

- Eliaibility
  - Those not receiving the Child Rearing Allowance because they are receiving a public pension
  - Those whose income has fallen to the level of those provided the Child Rearing Allowance due to the impact of COVID-19 and are now eligible for the Child Rearing Allowance
- Application deadline: February 26 (Fri.)

# Do not forget to complete the procedures to apply for the Admission Allowance for Single-Parent Families

- Eligibility: Those who have lived in Koka City (as registered residents)
  continuously for one year or more as of February 1, 2021, and are raising,
  as a single parent or in place of a single parent, a child entering an
  elementary school or junior high school in April 2021 \* There is no income limit.
- Application deadline: March 1 (Mon.)
  - \* Applications will not be accepted after the deadline.
  - \* Reception hours are from 8:30 to 17:15 (excluding Saturdays, Sundays and public holidays)
- Amount: Admission to elementary school: 5,000 yen Admission to junior high school: 10,000 yen
- Payment date: March 31 (Wed.), planned
- \* We will not notify eligible persons individually.

- National health insurance tax (11th term)
- Expenses borne by users (childcare fee, kindergarten/ nursery lunch fee)
- Long-term care insurance premium (11th term)
- Elderly medical care insurance premium
- Water charges

It is convenient to use account-to-account transfers for payments.

### Welfare Allowance for Children with Disabilities and Special Disability Welfare Allowance Systems



In order to reduce the burden caused by their disabilities and improve their welfare, Koka City provides the following allowances to persons with severe disabilities who remain at home and require constant nursing care.

For both allowances, certification with a medical certificate, etc., is required, and there is an income limit.

For details, contact the Independence Support Section.

#### Welfare Allowance for Children with Disabilities

- Eligibility: Those under 20 years of age who remain at home and require constant nursing care in their everyday lives due to severe mental or physical disabilities
- Amount: 14,880 yen per month

### **Special Disability Welfare Allowance**

- Eligibility: Those under 20 years of age who Those 20 years of age or older who remain at home and require constant specialized nursing care in their everyday lives due to extremely severe mental or physical disabilities
- Amount: 27,350 yen per month
