

Information on the Booster Shot (Third Dose) of the

COVID-19 Vaccine

For persons who received their second dose of the COVID-19 vaccine at least eight months prior and who wish to receive an additional dose, third-time booster shots will now be available. Eligible persons will receive their vaccination coupons in the mail roughly one month before they are able to receive their booster shot. Please be patient while we send out your coupons.

For those who moved to Koka City after receiving their second dose, those who were vaccinated in another municipality, and others in similar situations, we may be unable to confirm your vaccination record and so your coupon may not arrive.

If the time for your third dose arrives and you have not yet received a coupon, or if your coupon arrived but was lost or damaged, please contact City Hall.

Information regarding third-dose group vaccination venues and medical institutions distributing individual vaccinations will be included in the leaflet sent out with your vaccination coupon.

Other information on booster shots will be posted on the Koka City website and printed in the city newsletter as it becomes available.





We Will Reopen the "Koka City COVID-19 Vaccination Call Center" from Tuesday, January 4

To coincide with the start of booster shots of the COVID-19 vaccine, we will be reopening the call center to handle vaccination consultations and reservations.

(The call center will not be able to respond to individual inquiries regarding the distribution of vaccination coupons.)

Declaration of Depreciable Assets for Fiscal 2022

Fixed asset taxes are applied to not only land and houses, but also to depreciable assets such as factory machinery, exterior and paving for rental housing and parking lots, business assets such as solar power generation equipment, and so on. Asset owners are required to declare their assets held on January 1 of each year.

Persons (Individuals/Corporations) Who Need to Declare Their Assets Anyone running a business or operating a factory or store as an individual, or renting an apartment or parking lot, within Koka City as of January 1, and who owns business assets (including the lessors of such assets) Submission Deadline January 31 (Mon)

Supporting Child-rearing Households!

National Government System

Temporary Special Benefit (Advance Benefit) for Child-rearing Households

This is provided once to support the day-to-day lives of child-rearing households.

Eligible Children (1) Children who were eligible for child allowance (main benefit) for September 2021 and are aged 15 or younger

- (2) Children whose parents/quardians live in Koka City as of September 30, 2021, and who are aged 16-18 (born between April 2, 2003 and April 1, 2006)
- * Their parents/guardians' income must be within the monetary range of eligibility to receive child allowance (main benefit).
- (3) Newborn children who are eligible for child allowance (main benefit) and are (will be) born before March 31, 2022

Application Procedure No application is required for: Parents/guardians of either (1) or (3) Parents/guardians of both (1) and (2)

Application is required for: Parents of only (2) (i.e., children aged 16-18), civil servants receiving child allowance from the government agency where they are employed, etc. Please check the Koka City website or contact us for details.

Application Period Until March 31 (Thu)

Benefit Amount ¥100,000 per eligible child

Payment Date Of those who do not need to apply, child allowance recipients will receive the payment on Friday, December 24 at the end of the year in the account they registered to receive the child allowance.

Already notified in April 2021 Special Benefit for Supporting the Lifestyles of Childrearing Households (Both Single-parent Households and Other Households)

If you are eligible for benefits and have not yet applied, please do so before the deadline. *Please check the Koka City website or contact us for details regarding matters such as eligibility and application procedures.

Benefit Amount ¥50,000 per eligible child Application Period Until February 28 (Mon)

Be Careful! Those who received the child support allowance for April 2021 have already received the Special Benefit for Supporting the Lifestyles of Child-rearing Households, as have those who were exempt from residence tax in fiscal 2021 and received either the child allowance or the child support special allowance for April 2021.

Special Benefit for Assisting the Daily Lives of Child-rearing Households

Those receiving the Special Benefit for Supporting the Lifestyles of Child-rearing Households indicated on the above will also be eligible for an original Koka City allowance.



Benefit Amount ¥50,000 per household plus an additional ¥10,000 per child

Let's Make You an Individual Number Card!

POINT

- You can apply in several different ways!
- Your first application is free!
- About a month from application to receiving your card!



Application by Smartphone

STEP 1

Take a picture of your face using your smartphone camera

STEP 2

Use your smartphone's camera to scan the QR code on the Individual Number Card Application Form and access the application website.

STEP 3

Fill in the required fields according to the on-screen instructions and submit the form with the picture of your face attached.

Application by Mail

STEP 1

Fill in all required fields in the Individual Number Card Application Form and attach the picture of your face.



Check that there are no mistakes on the Individual Number Card Application Form, put it in the return envelope (enclosed with the application form) and send it by post.

*If it is within the city limits, you can make an application for an Individual Number Card at a post office the same as in City Hall.

Application Support for the Individual Number Card at the Counter



The applicant should bring the following required documents to Citizens' Affairs (Shimin Ka) or their local Community Civic (Chiiki Shimin) Center in person. Persons under 15 years old and legal wards should come in with their legal representative (person with parental authority, adult guardian, or equivalent).

STEP 2 Fill in the application form at the counter.

STEP 3 A staff member will take a picture of your face.

Required document(s)

- (1) Identification documents (one if it has a photo, two if not)
- (2) Individual Number Card Application Form

If you don't have an Individual Number Card Application Form on hand, you can get it reissued from Citizens' Affairs (Shimin Ka) or at any of the Community Civic (Chiiki Shimin) Centers in Tsuchiyama, Koka, Konan, and Shigaraki. If you make a request by telephone, it will be sent to your address by non-forwarding mail.

Let's Put a Stop to the Abuse of People with Disabilities

Your Report May Lead Directly to the Speedy Discovery and Speedy Handling of the Abuse

Abusers of people with disabilities are usually people close to the victim, such as a family member, and sometimes the victims themselves don't even know that what they are experiencing is abuse, or they cannot speak up for themselves. These factors mean that it is often difficult for cases of abuse to be discovered. For this reason, it is especially important that third parties notice the abuse early on and report it to the authorities, so that support can begin before the situation gets worse.

- If you find yourself thinking "Is that abuse...?" or if you have something you're concerned about, don't hesitate to ask for help.
- · Consultations can be anonymous. Confidentiality is strictly
- · Even if you're not sure if it's abuse, please speak up. You will not be penalized for making a false report.
- You can make a consultation without the consent of the disabled person or their family.

Keep an Eye Out for These! Tell-tale Signs of Abuse

- ☐ They make a move to cover their head even in response to a slight raising of the other person's hand.
- ☐ They have experienced an unnatural increase or decrease in weight.
- ☐ They suddenly become frightened or scared.
- ☐ They are always wearing the same clothes.
- $\hfill\Box$ Their hair and nails are overgrown, or their skin is dirty.
- ☐ Their family is controlling their pension (or other such payment) and seem to be using it for their own daily expenses or gambling or the like.
